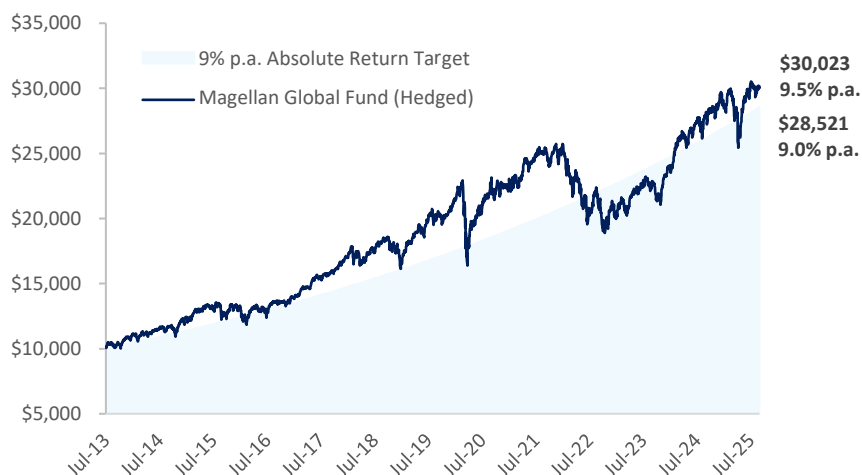

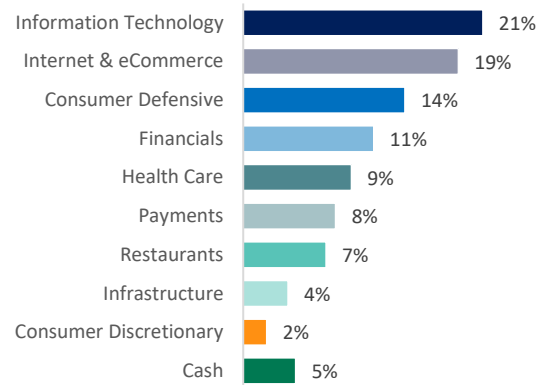

### SECTOR EXPOSURE BY SOURCE OF REVENUE<sup>3</sup>



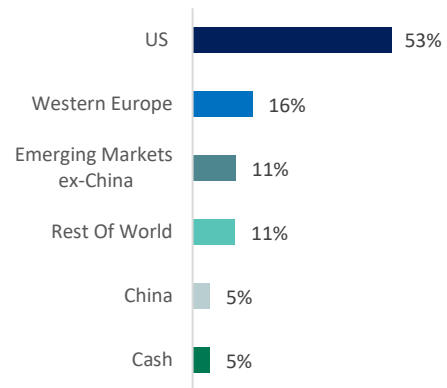
