All fees are inclusive of the net effect of GST. Effective 1 July 2024, the management fee was reduced from 1.05% p.a. to 0.75% p.a. and the performance fee changed from '12.5% of the excess return of the Fund above the "Absolute Return" hurdle of 10% p.a.' to '10% of the excess return of the Fund above the MSCI World Net Total Return Index (AUD)'. Effective 15 September 2025 the performance fee was removed.

Effective 15 September 2025 the management fee was reduced from 1.50% p.a. for Class A and 0.78% p.a. for Class B to 0.75% p.a. and the performance fee was removed. Additionally, performance fees were subject to a high water mark; The Class B performance fee was 20% of the excess return of the Class B Units of the Fund above the Absolute Return Performance Hurdle of 10% p.a. Additionally, performance fees were subject to a high water mark and a cap of 2.22% p.a. From 15 August 2025 to 14 September 2025, the performance fee for the Fund was waived.

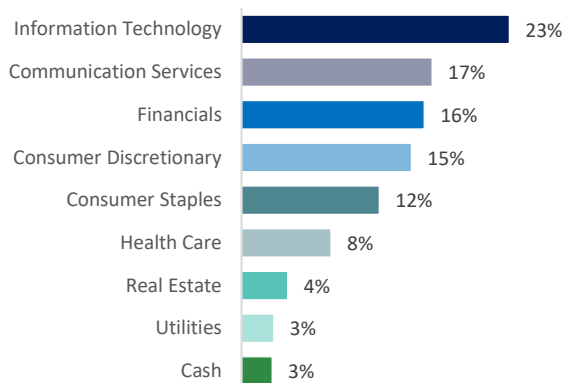

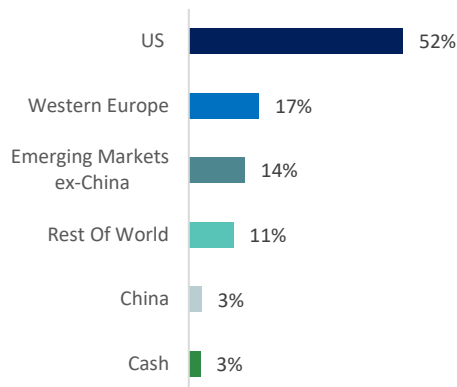
SECTOR EXPOSURE⁴

PORTFOLIO ACTIVITY - JUNE QUARTER 2026

No new stocks were added to the portfolio in the June quarter, although we boosted our holdings in several existing holdings reflecting higher conviction in these companies. These included Netflix, with the streaming entertainment leader trading at a below market valuation despite its strong outlook for revenue growth and margin expansion; and Intercontinental Exchange, the US listed exchange group that owns the New York Stock Exchange and multiple futures exchanges globally and benefits from market volatility.

In contrast AIA Group, the pan Asian Insurer, was exited on valuation grounds following strong performance, while Diageo, the UK listed spirits giant, was exited due to ongoing weakness in alcohol consumption.
