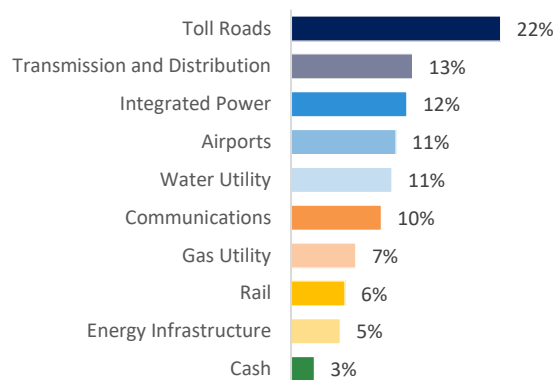

SECTOR EXPOSURE³



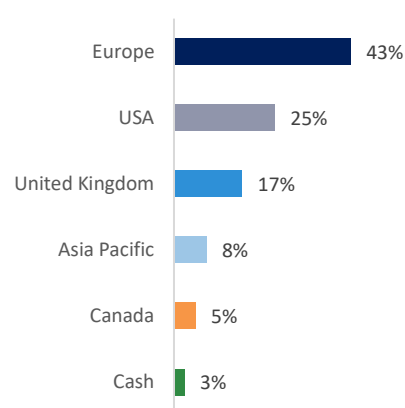
