The Underlying Fund's universe of investible securities is the 300 largest listed companies on the ASX, resulting in exposure to over 120 securities. 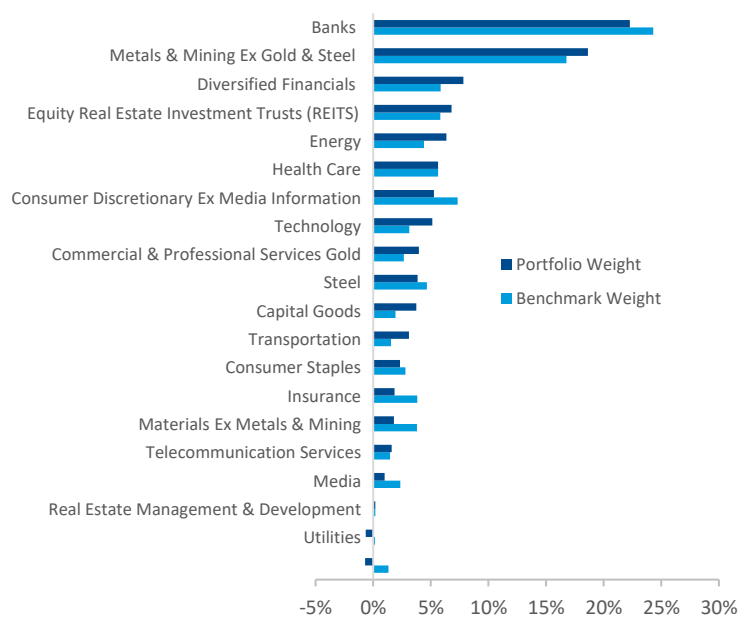
