- Under 'Issuer', enter the name of a Barrenjoey fund held through your Primary Entity
- Under 'Holder Number' enter your Primary Entity SRN listed above
- Under 'Partial Holder Name' enter the Primary Entity name (or part of it)

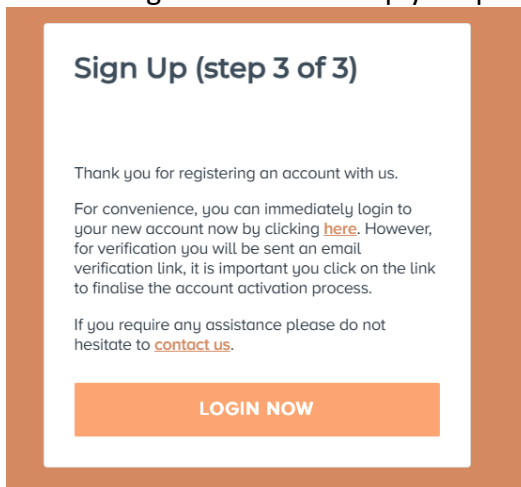

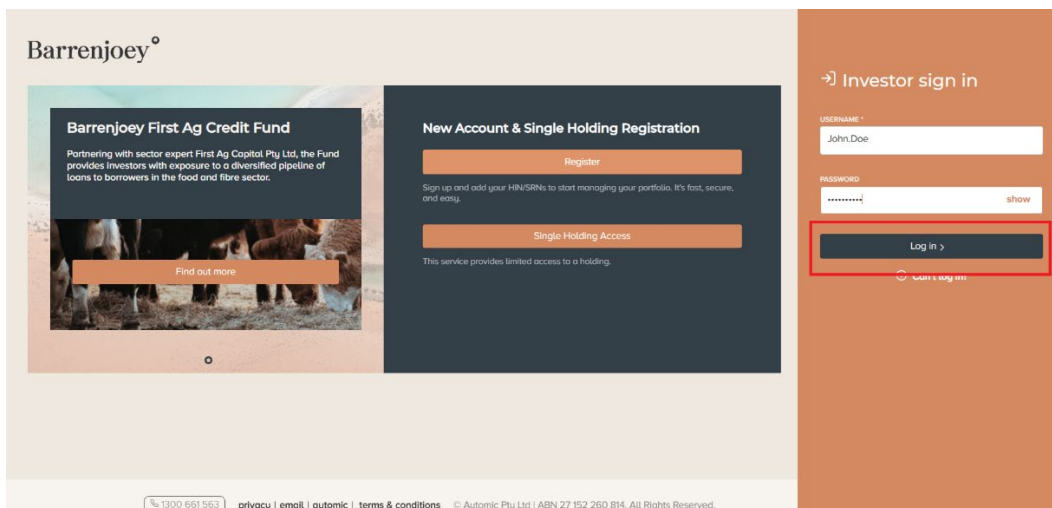

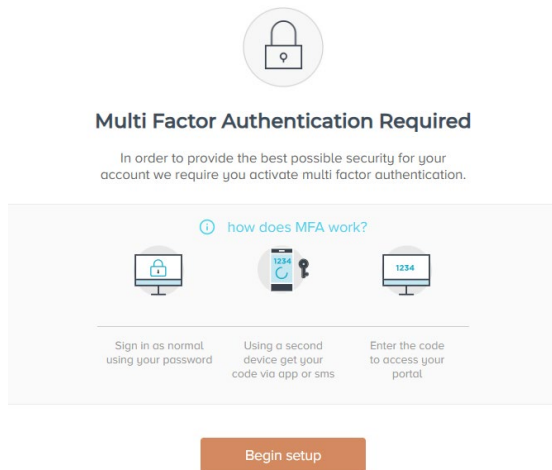

How to set up your multifactor authentication (MFA)

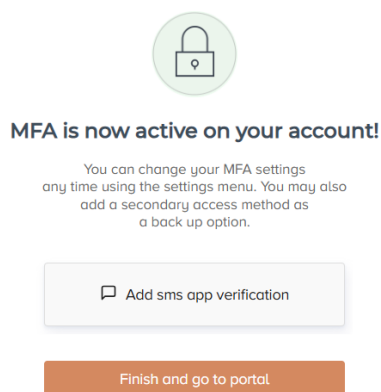
1. After you have logged in for the first time, you will be prompted to set up MFA

3. Select your preferred MFA method



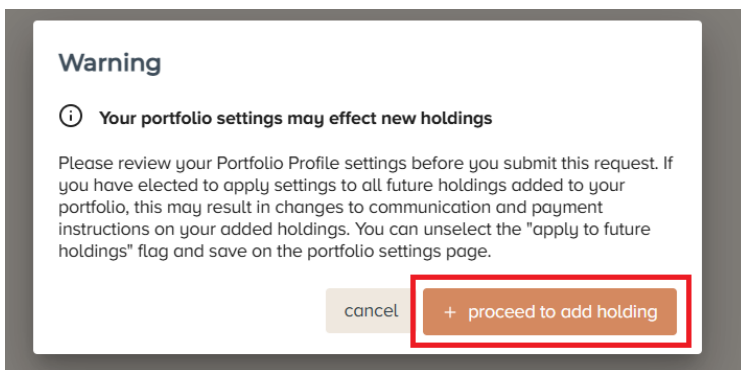
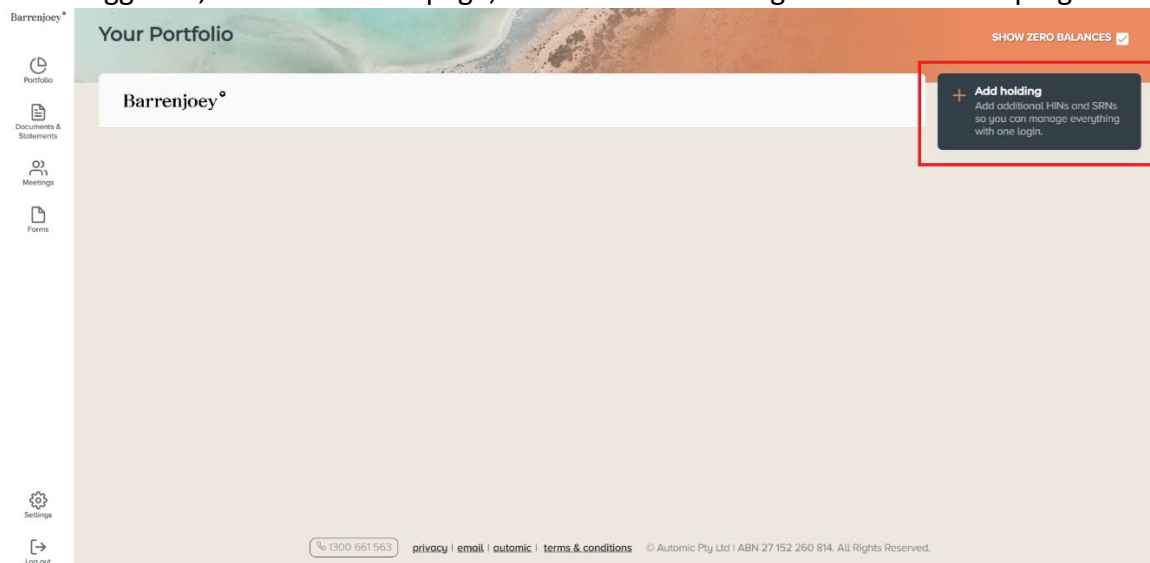
4. Once you have completed the setup, click Finish and go to portal

3. Enter the SRN of the Additional Entity
4. Click 'Submit Request'

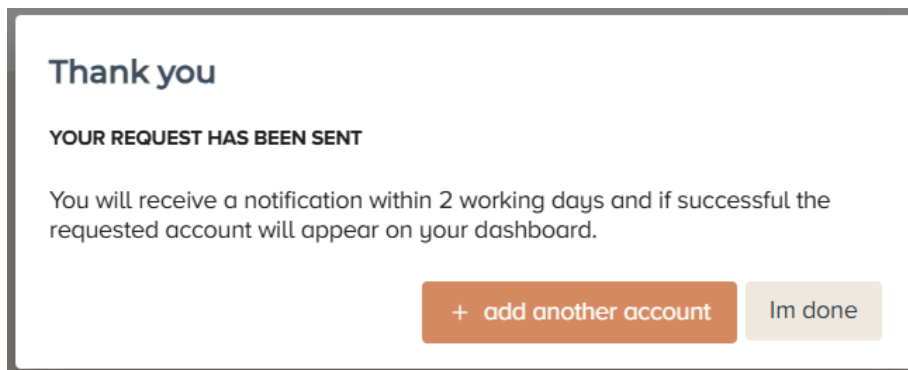

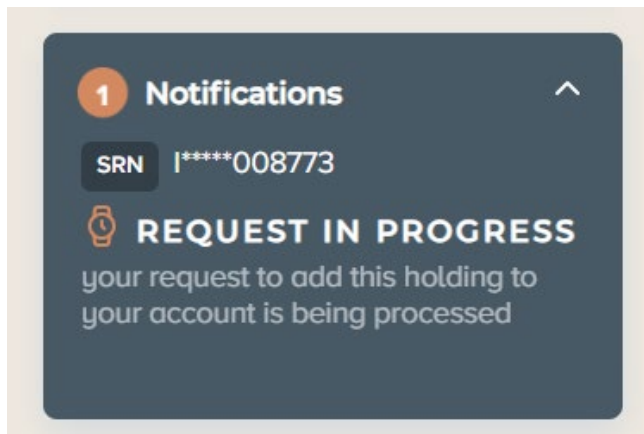
