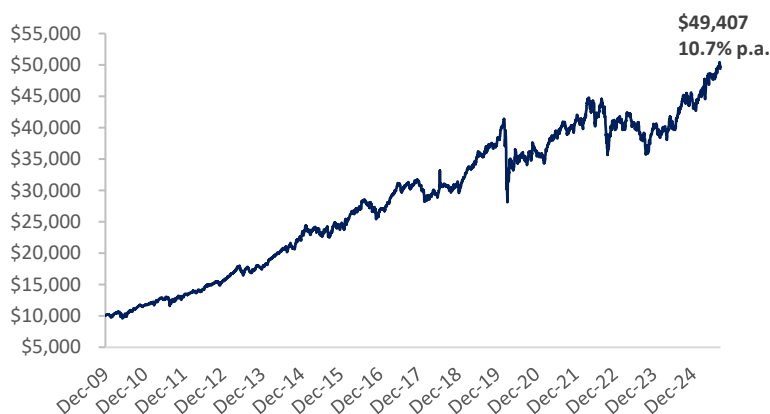

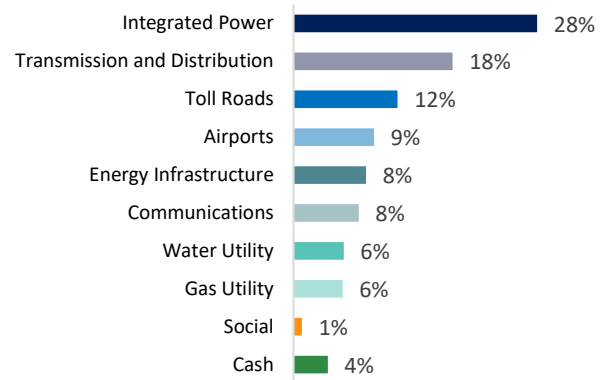

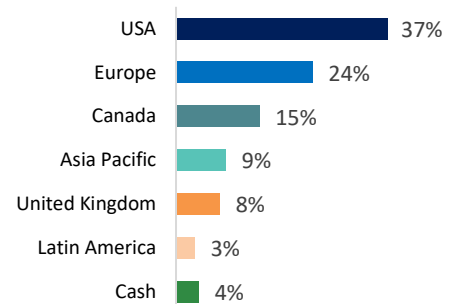
SECTOR EXPOSURE⁴
